

Delivery Times: Delivery and lead times for OFF-DUTY PROGRAM orders depend upon our inventories and weapons on order.

OFF-DUTY PROGRAM Prices: OFF-DUTY PROGRAM pricing is set by SIG SAUER. The OFF-DUTY PROGRAM sale price will vary but it's usually between \$150.00 - \$575.00 off MSRP depending on the model. Reach out to a qualified dealer for model-specific pricing.

Purchasing Process for OFF-DUTY PROGRAM: Customers are required to show proof of eligibility to qualify for The OFF-DUTY PROGRAM. Both the dealer and qualified individual will be required to fill out and follow the directions on the OFF-DUTY PROGRAM form and attached it to the 4473. The completed OFF-DUTY PROGRAM form will need to be kept with the 4473 on file.

OFF-DUTY PROGRAM Sales: OFF-DUTY PROGRAM sales are designated for the qualified individuals listed below. When advertising or selling online Dealer must note that sales are for OFF DUTY individuals only and that proof of eligibility is required.

Agency Sales: Sales to an agency or department are prohibited. The OFF-DUTY PROGRAM is for qualified individuals to purchase select SIG SAUER products for individual use. For any request for agency related sales please contact your SIG SAUER Representative.

Violations and Audits: SIG SAUER will reserve the right to perform audits on the dealers' sales of the OFF-DUTY PROGRAM. If it is determined that a dealer is in violation of the terms of the program the dealer will be removed from taking part in the OFF-DUTY PROGRAM until further notice.
