
OPERATION

Installation

Step 1 - Sight Height

Your JULIET-MICRO comes configured for 1.41" absolute co-witness, but also includes spacer kits for 1.535" and 1.63" lower 1/3rd co-witness. Determine the sight height of your red dot and adjust your JULIET-MICRO sight height accordingly by using the spacer kits provided. The 4 mounting screws should be torqued to 13 in-lbs.





Step 2 - Install on Rail

Locate your JULIET-MICRO behind your red dot under the following considerations:

- 1. Charging handle should be accessible
- 2. Eye relief is optimal when firearm is shouldered
- 3. Magnifier does not interfere with red dot or other accessories while using flip-toside feature

Once the correct rail position is determined for the JULIET-MICRO you may need to move the red dot.


Once both positions of the JULIET-MICRO and your red dot are determined, torque 1/2" hex nut to 65 in-lbs. If your red dot was removed or repositioned during this the process, re-install per manufacturer's specifications.

Step 3 - Center Elevation & Windage

Ensure that your red dot is zeroed.


Using the JULIET-MICRO elevation and windage adjustments, rotate one at a time until the red dot is centered in the field of view.

Note: The JULIET-MICRO adjustments will not affect Point of Aim (POA). You will need to make those adjustments on the red dot.




Step 4 - Set Diopter

JULIET-MICRO comes with an adjustable diopter. To adjust diopter, rotate the eyepiece until the red dot reticle is crisp and clear.



Step 5 - Flip-to-Side Mount

JULIET-MICRO magnifier comes installed to a push-button, flip-to-side mount. Simply press the button to go from engaged to disengaged.

Seeing "scope shadow"	Turn JULIET-MICRO elevation and windage adjustments until dot is centered in field of view	
	Ensure JULIET-MICRO is configured to match red dot sight heights of 1.41 in, 1.535 in, or 1.63 in.	
Charging handle is inaccessible	Move JULIET-MICRO forward on rail until charging handle is accessible	
Lens is cloudy or dirty	Clean both lenses with provided lens cloth
